1. Homes purchased from the developer will be issued two access cards and two transponders at no charge.
2. Homes purchased from a resale or are leased will be issued access cards to household members 16 years and older at \$10.00 each. Proof of age and photo ID is required. Transponders will be issued with vehicle registration in the name and address of the Olympia resident at \$40.00 each.
3. Proof of residency and picture ID must be provided to receive an Access Card. Cards are not transferable and can be confiscated if someone other than the register card holder is found using the Card.
4. Only residents that currently reside in the community are eligible to receive an Access Card.
5. Guests of Residents must be accompanied by the resident and are limited to the use of pool, tennis courts, grounds and basketball courts. Guests may not use the Fitness Center.
6. Use of the facility is limited to posted hours.
7. Facility may at any time be under surveillance. This is to curb vandalism and disruptive behavior and should in no manner be considered security.
8. Please assist us in maintaining a safe and enjoyable facility for all members b adhering to our policies.
9. Please do not litter the grounds or clubhouse at any time.
10. Smoking is allowed in designated areas. No smoking is allowed within the Pool gates.
11. Villa Olympia staff reserves the right to require any residents or guests that do not abide by Club policies to leave the facility.
